The terms and conditions are given below:

- 1) Persons/firms, interesting in purchasing the above mentioned vehicle, may submit their highest quotations in the enclosed Proforma in a sealed cover addressed to the undersigned latest by 3:00 P.M. on or before 4<sup>th</sup> December 2020 at office of PBTI Mohali. The bidders or their representatives, not more than one for each quotation, may be present, if they so desired, at the time of opening of quotations. The cover should be prominently superscripted with the words **“QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE NO. CH01 G1 1628”**.
- 2) The vehicle will be available for inspection between 10.00 AM to 1:00 PM on any working day in presence of the Administrative, Finance and Accounts Officer, PBTI.
- 3) The tender for disposal of said vehicle will be governed by the following conditions:-
  - i) The vehicles will be sold on “As is where is basis”. The tender process will be conducted in presence of Disposal of Vehicle Committee.
  - ii) The bidders are required to deposit Earnest Money amounting to Rs. 14,125/- (Rupees Fourteen Thousand One Hundred and Twenty Five Only). Earnest Money is payable by means of Demand Draft drawn in favour of Punjab Biotechnology Incubator (payment by cheque or cash shall not be accepted). The quotations received without demand draft will not be considered and shall be rejected.
  - iii) The successful bidder will be required to deposit the bid amount by means of Demand Draft drawn in favour of Punjab Biotechnology Incubator within 72 hours of the acceptance of bid.
  - iv) The Earnest Money of the successful bidder will be released only after the deposit of bid amount. Earnest Money will not be adjusted as bid amount and will be forfeited, if the successful bidder fails to honour the bid.

- v) The delivery of the disposed vehicles will be arranged only after the successful bidder submits documentary evidence in support of residential status (PAN card, Aadhar Card etc. in case of individual and Registration Certificate in case of firms).
- vi) The disposed vehicles will be lifted by the successful bidder within 72 hours of depositing the bid amount, at their own expenses.
- vii) The vehicles will be disposed off on "as is where is basis" and no guarantee for its worthiness or quality will be given by this Department.
- viii) This Department will not owe any responsibility for transfer of vehicle and for any other liability for using these vehicles for commercial or any other purpose after sale.
- ix) The successful bidder will also be responsible for getting Registration Certificate of the vehicles and /or any other documents as required by the RTO, in his name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard. All legal formalities have to be completed by the successful bidder at his own cost.
- x) The successful bidder/buyer shall not be allowed to ply the vehicle on road using the existing Govt. Number plate and any such instance shall be considered as misuse of Govt. auctioned vehicle and legal action will be taken against the violator.
- xi) If the successful bidder wants to scrap the vehicle, then he should have to submit the cut part of the chassis number to this office immediately.
- xii) The bidder will not be allowed to withdraw their bids and if they do so their earnest money will be forfeited.
- xiii) The Bid amount is excluding GST, as the GST is to be paid by the recipient of the goods as per the rates applicable.
- xiv) The undersigned reserves the right to accept or reject/all the bids, amend/withdraw any terms and conditions in the Tender document or to cancel the Tender without assigning any reason and the decision of the undersigned shall be final and binding.
- xv) The successful bidder will sign the agreement within 24 hours of acceptance of bid for sale/purchase and the cost of agreement is to be borne by the bidder.
